6.1 Team Captain / Festivals:

Annette reported: June 5/6 will be CCS River City, held at Lake Shirley in Winnipeg. The Early Bird fee of \$900.00 is due on April 15th and will be paid. Annette has 17 members signed up and 1 a question. Two members can only do Saturday and 5 have not responded. We need a minimum of 16 paddlers plus drummer and steer. She has 6 rooms blocked at Super 8 on 1485 Niakawa Road (204-253-1935) at 109.00. Please book room under Annette Beatty or Waves of Hope with your own credit card. Registration would be 500. 00 if each team member raised 135.00 in pledges. At this time we are selling begonias and Fashion Show so we are not getting pledges.

Sept. 12/13: FMB Manitoba Dragon Boat at the Forks. Registration of 900.00 has been paid June 16/14 and we are Team 4 with a free tent spot.

Sept. 11/12: CCS Sept. Challenge Small Boats (Registration: 350.00 due July 4/15). Conflict with FMG. If we had too many paddlers we could do this with 10 paddlers but not feasible at this time.

Out of Town festivals: Lethbridge - June 26 - 28; Saskatoon - July 24/25 - 900.00; Calgary: - Aug. 22 /23 - 800.00 plus 300.00 tent. Free transit from Delta Hotel - 129.00 rate.; Edmonton - Aug. 14 - 16. Registration opens April 30th. Last year: 1100.00 plus 275.00 for 1/2 tent space. Prairie Coach Bus Quote: 30 people - 5460.00 plus driver room.; Regina: Sept 4/5 - Friday night and Saturday. early Bird: 630.00 to April 30, after: 787.50. Annette will do a festival survey at the AGM. If enough interest we could attend one of these festivals.
