 - **5.7.1 Team Shirts:** Joyce has been checking into sources for new shirts. She has contacted Regent Custom Cresting and Just Stitching in Brandon but so far has received no reply. Atac, a company in Langley, B.C. seems to have what we are looking for, a quick

drying polyester paddling shirt with longer back. They dye the material to match our sample so there would be no difficulty getting our colour. The support members could have white with pink lettering. The cost will be considerably more than that of our present t-shirt, as the polyester shirt starts at \$32 and with our logo and printing would likely be in the \$40 range. This would require that each member contribute at least \$25 towards the cost of her shirt. It is felt that we should have input from the members so Joyce K will send out an e-mail with this info and it can be discussed at the Y on Wednesday night.
