charities, the MPA has a 3 year contract with the agencies presently sponsored so there will be no change this year.

6.2 FMG Festival's Rose Ceremony:

There has been an invitation received to a meeting June 14, 2004 in Winnipeg to discuss concerns arising from the rose ceremony at last year's FMG Festival. The ceremony, initiated to honour breast cancer victims and survivors, was opened to include anyone associated with cancer including support agencies. The result was that there were paddlers taking part in the ceremony who have never had the disease while a Chemo Savy team remained on shore. Someone from Waves of Hope will be at the meeting.

In the course of preparing thank you letters for the many contributors to the Fashion Show, Marg S. has redesigned the letterhead. Suggestions were made for further changes and approval given for her to have 100 printed immediately for these thank yous which number more than 80.
