10.5 Festivals and Demonstrations

Jody P. joined us by speaker phone and gave the following report:

Survey: 13 responses have been received to date. Brandon is the first choice with Regina and Winnipeg coming next. Winnipeg has more than Regina. The majority have voted yes to Nova Scotia- more info will be needed as for cost, exact date. We do need a plan if attempted. We need a strong team commitment for fund raising and how much individuals are willing to pay themselves or how much is expected from the team.
